CASE

Businesses in the fictional countries of Zor, Utopia, and Orlon have not begun to trade across national boundaries. Economic conditions in these countries are as follows:

A. Zor's economy depends upon high technology. Each home has a flatscreen television, several laptop computers, two to five telephones, a home theater, and a sophisticated burglar alarm system.

The labor force is skilled in the area of electronics. It depends on mass transportation to and from work because of a shortage of fuel. Absenteeism is a problem, and sales of electronic equipment have dropped 15 percent a year for the past two years. Unemployment is increasing.

The country has few beaches, resorts, or fishing lakes. Its shipping industry is practically idle. However, its military is highly developed.

B. Utopia, a large country, is basically agricultural. Its fields provide plenty of grain for cattle, and its many rivers and lakes provide year-round fishing.

The people of Utopia are technologically unskilled and must spend most of their time taking care of the production and preparation of their food. With little income and leisure time, they seldom enjoy the beaches that surround the country.

C. Orlon is a small, but rich, country. It has an abundance of oil and coal but little technology for refining them. A few rich landowners have small oil wells, but most of the resources remain buried.
